

Terms and Conditions for Moments that Matter Bonus Draw - Draw 558

1.0 General

- 1.1 These terms and conditions for the **yourtown Bonus Draws in Draw 558** form part of the General Terms and Conditions for **yourtown** Prize Home Draw 558 <https://yourtownprizehomes.com.au/win> Entry into these draws detailed in these terms and conditions is deemed acceptance of these Terms and entrants warrant that they are not prohibited from accepting a prize.
- 1.2 The **Moments that Matter Bonus Draw** is a Trade Promotion licence no ACT TP26/01088 within the yourtown Prize Home Art Union Draw 558 under the following permit numbers Qld Licence 29586, ACT R26/00083, NSW Licence GOCAU/2322, VIC Permit MG-R26344413, SA Licence M15009.
- 1.3 These Art Unions are run by **yourtown** ABN 11 102 379 386 of 5 Cordova Street, Milton Qld 4064.
- 1.4 Subject to satisfaction of the eligibility criteria, entry into the Moments that Matter Bonus Draw will be automatic for supporters who hold a **yourtown** myplace membership for the listed draw in Section 2.1.4.
- 1.5 The **Moments that Matter Bonus Draw** will be drawn by electronic draw at 6am AEST at **yourtown**, 5 Cordova Street, Milton Qld 4064 on the stipulated dates listed in Section 2.1.8.
- 1.6 Winners will be announced on the day of each draw and published on the **yourtown** website at yourtownprizehomes.com.au/winners. Winners will be notified via phone and in writing by email and post (where applicable) on the day of the draw.
- 1.7 Unclaimed Prizes in ACT/NSW - If a prize is unclaimed in the ACT or NSW within 3 months of the draw date, **yourtown** will comply with the terms and conditions stipulated by ACT Gaming and Racing Commission in relation to a redraw.
